A portion of your organization's annual membership dues may be tax-deductible as a business expense. An estimated six percent of your dues will be spent on lobbying efforts in the following year. Because the Chamber does not provide tax advice to its member organizations, please consult your accountant or attorney to determine the precise amount your organization may deduct.

Your organization's membership in the Greeley Chamber of Commerce will be renewed each year unless written notice of cancellation is received at least 30 days prior to the organization's annual renewal date. Member organizations that do not submit written notice of cancellation of membership to the Chamber at least 30 days prior to the annual renewal date are responsible for payment of the amount of their previously agreed annual investment.

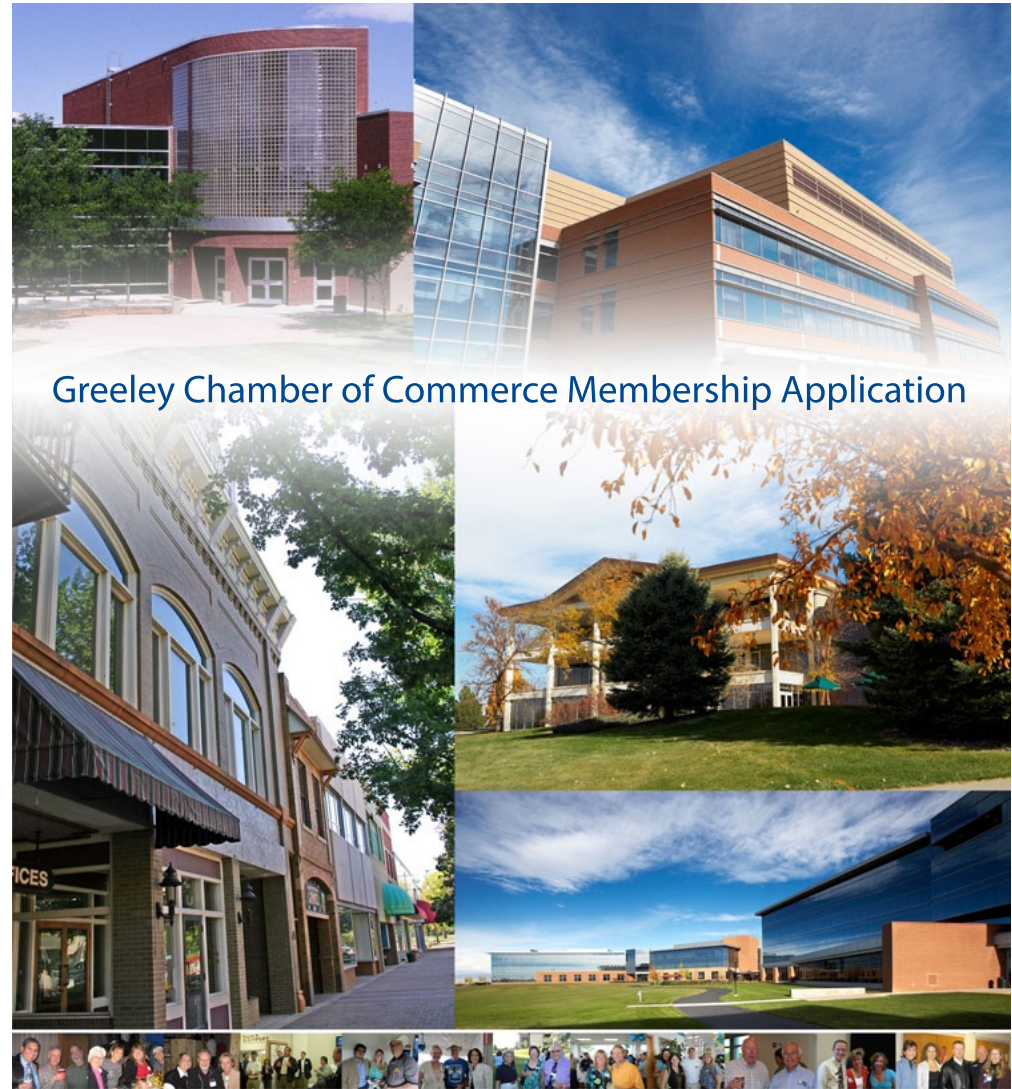
